Medical assistants are multi-skilled practitioners who assume a wide range of roles in physicians' offices and other health care settings.

Medical assistants can demonstrate their knowledge of and commitment to professionalism by earning the CMA (AAMA) credential. The CMA (AAMA) is awarded to candidates who have successfully completed the CMA (AAMA) Certification/Recertification Examination administered by the Certifying Board of the American Association of Medical Assistants. The CMA (AAMA) is evidence of competence in a demanding field.

The CMA (AAMA) enjoys increased respect and recognition from professional peers. Employers recognize the value of the credential. The CMA (AAMA) also benefits from broader career advancement opportunities and enhanced job security. The skills of the CMA (AAMA) are in demand in a wide range of health care delivery settings. And, the credential is valid wherever the medical assistant goes.

## Testing for Today's Standards


The CMA (AAMA) Certification/Recertification Exam is a comprehensive test of the knowledge actually needed in today's medical office. The content is drawn from an in-depth analysis of the numerous general, clinical, and administrative tasks medical assistants perform on a daily basis. The consultant for the exam is the National Board of Medical Examiners (NBME), the leading organization responsible for testing physicians nationwide.

Exam questions are formulated by the Certifying Board's Task Force for Test Construction (TFTC). This group is composed of practicing medical assistants, physicians, and medical assisting educators from across the United States. Working with NBME, the TFTC updates the CMA (AAMA) Exam to reflect changes in the day-to-day responsibilities of medical assistants, as well as the latest developments in medical knowledge and technology. The exam tests knowledge in three major areas:

- **General medical knowledge**, including terminology, anatomy, physiology, behavioral science, and medical law and ethics
- **Administrative knowledge**, including medical records management, collections and insurance processing
- **Clinical knowledge**, including examination room techniques, medication preparation and administration, pharmacology and laboratory procedures

To be eligible for the CMA (AAMA) Exam, an applicant must be a graduate of a medical assisting program accredited by the Commission on Accreditation of Allied Health Education Programs (CAAHEP) or the Accrediting Bureau of Health Education Schools (ABHES).

The exam is offered year-round at testing centers nationwide. To help applicants

### Recertification: To Stay a Step Ahead

Being a health care professional today means maintaining a lifelong commitment to high standards of practice. The CMA (AAMA) is required to recertify every 60 months to keep the credential current. Any CMA (AAMA) must have current status in order to use the credential. Certification status is a

matter of public record and may be released, and also verified on the AAMA website.

Recertification reinforces the validity of the credential and helps maintain its continued acceptance by physicians, patients, and other allied health professionals.

The requirement can be met in either of two ways:


- By earning 60 recertification points through continuing education
- By passing the CMA (AAMA) Certification/Recertification Exam

Those who elect the continuing education route can choose from hundreds of courses sponsored by local, state, and national AAMA groups. They can take advantage of continuing education articles published in each issue of *CMA Today*, the AAMA's bimonthly publication. Self-study courses are also available through the AAMA Continuing Education Department.

With over 230 chapters nationwide, AAMA is the premier organization serving the professional interests of medical assistants. The AAMA provides numerous services that help medical assistants put their careers on a successful and rewarding track and keep them there.
